

To increase railway connectivity throughout the GMS in order to promote efficient, safe, and environmentally sustainable rail transport of goods and people with and beyond the subregion.








Background of the Greater Mekong Railway Association (GMRA)

# Key Agreements on the GMRA



- Proposal to establish GMRA was ratified at the 18th GMS Ministerial Meeting, Nanning, PRC 12-13 December 2012.
- MOU establishing the GMRA was signed by all countries – this was completed on August 8, 2014
- GMRA membership comprise the 6 GMS countries as the founding members.
- GMRA initially established as a <u>non-legal</u> intergovernmental forum under the GMS Program with ADB providing secretariat functions
- Medium term goal is to create the GMRA as a <u>legal</u>, international organization



## **Outcome of TA 9123-REG**

Connecting the Railways of the Greater Mekong Subregion (First Phase)

- Prioritization of the 9 cross-border rail links
- Pre-Feasibility Study assessments of each
- Development of a multi-modal GMS transport demand model



## **Outcome of TA 8748-REG**

Appendix I to the Framework Agreement

- Prepared the <u>draft</u> Framework for Cross-Border Railway Transport Connectivity Agreement (CBRTCA)
- The agreement when finalized will provide a high level strategic framework agreement for cross-border rail transport supplemented by a series of protocols (see on right)
- On 24 May 2019, GMS countries further negotiated the CBRTCA in ADB HQ, Manila but some details remain to be resolved.

# Connecting the Railways of the Greater Mekong Subregion (Phase 2) (May 2020 – Dec 2021)

- 1. Organizational structure of the GMRA improved
- 2. Operational readiness plan for the GMRA developed
- Outputs 3. GMS railway network development strategy updated
  - 4. Updated GMS transport demand model prepared
  - 5. Bankable railway projects identified in GMS countries

Outcome GMRA functioning with adequate capacity and funding

- In addition to the 5 outputs described a new output has been added "<u>A1:</u> <u>Framework Agreement for</u> <u>the CBRTCA Finalized</u>" through up to 3 negotiations in 2021
- Rationale: the CBRTCA is a critical instrument to operationalize the GMRA as a legal, international organization with permanent staff and sustainable funding ADB
